



# SIA Annual Subscriptions & Joining Fees

## SIA Membership Categories

The SIA has four categories of membership as follows:

**SIA Member** - manufacturers, distributors and suppliers of stoves (both space heaters and boiler stoves), flue and chimney products, component parts and fuel.

**SIA Stakeholder Member** - advisory, notified and certification bodies, sweep associations and other interested parties.

**SIA Associate Member** - (known as SIA Retail Group) retailers with physical showroom premises in the UK.

**SIA Supporter Members** - retailers with physical showroom premises in the UK.

### Annual Subscriptions SIA Member

Manufacturers, distributors or suppliers with a Group turnover of >£5m **£4,500 +VAT**

Manufacturers, distributors or suppliers with a Group turnover of >£1.5m and <£5m **£3,750 +VAT**

Manufacturers, distributors or suppliers with a Group turnover of <£1.5m **£3,250 +VAT**

**Plus, all applications to become a Member of the SIA will be subject to a Joining Fee equivalent to one year's Annual Subscription**

### Annual Subscriptions Associate Member (SIA Retail Group)

Retailer - one shop Single annual payment **£660 inc. VAT (£550 exc. VAT)**

Retailer - one shop Monthly Direct Debit **£60 inc. VAT**

Retailer - more than one shop Single annual payment **£1,080 inc. VAT (£900 exc. VAT)**

Retailer - more than one shop Monthly Direct Debit **£95 inc. VAT**

### Annual Subscriptions Supporter Member

All Supporter Members - one showroom only **£120 inc. VAT (£100 exc. VAT)**

### Annual Subscriptions Stakeholder Member

All Stakeholder Members **£3,250**

**Plus, all applications to become a Stakeholder Member of the SIA will be subject to a Joining Fee equivalent to one year's Annual Subscription**

# SIA Annual Subscriptions & Joining Fees

## IMPORTANT NOTES:

- A business which manufactures or distributes any stoves or fireplaces, whether or not this is their main line of business, is treated as an appliance manufacturer or distributor for the purposes of annual subscriptions.
- Turnover for SIA Members is based on group turnover, including any group turnover which may be outside of the stove or fireplace industry.
- The joining fee for SIA Members and SIA Stakeholder Members is considered appropriate as all new SIA Members and SIA Stakeholder Members will immediately receive the benefits of previous work the SIA has done to promote the industry and represent the industry position on regulations, and which has been funded by past subscriptions of existing members.
- The membership year varies by category as follows:
  - SIA Members and SIA Stakeholder Members - 1st July to 30th June
  - SIA Associate Members - 1st September to 31st August
  - SIA Supporter Members - on the 1st day of the month of sign-up.
- A pro-rata charging process is used for SIA Member, SIA Associate Member (not paying by direct debit) or SIA Stakeholder Member fees when joining part way through a membership year. Renewal thereafter will be in line with the dates shown above. The joining fee for Members and Stakeholder Members is based on a full membership year and is not pro-rata.
- Direct Debit payment is only available to SIA Associate Members.
- All SIA membership types are full year contracts and we are unable to offer partial refunds.
